1. All rebate requests must be submitted for installations that have been complete for no more three months; this means that all HVAC and water heating equipment is installed in its final condition. If a job has been complete for more than three months, it will not be eligible for rebates.
2. Tankless water heaters are not eligible for rebates.
3. Heat pumps and water heaters must be new equipment that has never been previously used.
4. Mini-split systems ducted/ductless are eligible for rebates.

Existing Home Improvement Rebates

Heat Pumps:

Electric to electric change out: 14 SEER \$50/ton (\$200 max); ≥15 SEER \$75/ton (\$300 max)

Electric heat pump replacing existing heat pump, electric resistance heat or wood heat.

Electric replacing gas heat: 14 SEER \$75/ton (\$300 max); ≥15 SEER \$125/ton (\$500 max)

Electric heat pump replacing natural gas, propane gas or oil heat as the primary heating system.

Geothermal heat pump \$250/Ton; \$350/ton replacing gas

A certified geothermal dealer must do geothermal system replacing any type of system and installation.

Water Heaters:

Electric water heater must be at least 30-gallon capacity and have dual heating elements.

Electric to electric change out \$75 per unit; \$150 for Lifetime Warranty or Heat Pump Water Heater

Electric water heater replacing existing electric water heater.

Electric replacing gas \$300 per unit; \$500 for Lifetime Warranty or Heat Pump Water Heater

Electric water heater replacing gas water heater.

Thermostats:

Programmable thermostat with adaptive recovery \$25

Insulation:

Bring attic insulation up to R-38 level/foam attic trusses \$300/\$500

Total Leakage Reduction (Ducts/House Combined):

Reduce leakage by ≥20% \$600

Reduce leakage by ≥25% \$800

Reduce leakage by ≥30% \$1,000

- Blower door and duct leakage tests must be performed and results forwarded to Diverse Power Inc. prior to any measures or improvements being considered for reimbursement. Failure to do so will result in disqualification from whole house improvement rebates.
- Replacement rebates based on number of units being replaced. Rebates include mini-split systems ducted/ductless.
